

# RIDESHARE DRIVER SURVEY SWEEPSTAKES OFFICIAL RULES

Here are the prize drawing rules for the Rideshare Driver Survey Sweepstakes.

## SWEEPSTAKES OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN.

OPEN TO DRIVERS 18 YEARS OR OLDER WHO HAVE DRIVEN FOR UBER AND/OR LYFT IN THE LAST 4 YEARS WHO COMPLETE THE SURVEY.

**Entry.** NO PURCHASE NECESSARY TO ENTER OR WIN. You may enter by completing the survey and providing your name and contact number for the last survey question which confirms that you would like to enter the sweepstakes. The survey takes 15-30 minutes and asks questions about your experience driving for Uber and/or Lyft. The survey may be completed online at [bit.ly/ridesharesurvey2022](https://bit.ly/ridesharesurvey2022).

**Sponsor and Survey Partners.** Asian Americans Advancing Justice – Asian Law Caucus (“ALC”) is the Sponsor of this contest. Our Survey Partner is Rideshare Drivers United.

**Deadlines.** The sweepstakes begins when the Survey is launched in April 2022 and ends on May 20, 2022 (the “Entry Period”). All entries must be received by 5:00 PM (Pacific Time) on the last day of the Entry Period. The Sponsor is not responsible for entries that are late, lost, stolen, misdirected, non-deliverable or illegible due to any reason whatsoever. Unlawful, unintelligible, illegible, or incomplete entries will be disqualified. Entries become the property of the Sponsor and will not be returned.

**Eligibility Requirements.** VOID WHERE PROHIBITED OR RESTRICTED BY LAW. This sweepstakes is open only to persons age 18 years or older who have driven for Uber and/or Lyft in the last 4 years and have completed the Survey. Entries without a name and contact number submitted for the last survey question confirming the desire to enter the sweepstakes will not be accepted for entry into the Sweepstakes. Employees of the Sponsor or the Survey Partner, and any of their immediate family members, are *not* eligible to enter. The Sponsor reserves the right to require the winners to complete an affidavit to confirm eligibility under these rules.

**Prize.** Five (5) prizes will be awarded to five winners drawn at random. Each prize is a \$100 Visa Gift Card.

**Selection and Notification of Winners.** The winners will be selected by a random drawing, conducted by the Sponsor on or about June 1, 2022. The winners will be notified by telephone using the name and telephone number the applicant provides on the completed survey. The notification will direct the winners on how to redeem their prizes. If a potential winner of a prize cannot be contacted within ten (10) days or

if the prize is unclaimed or returned as undeliverable, the potential winner is disqualified. If it is necessary to select an alternate winner, the same procedures discussed above will be used for the selection. The prizes are guaranteed to be awarded. THE PRIZES INCLUDE ALL SHIPPING AND HANDLING CHARGES. FEDERAL, STATE AND/OR LOCAL TAXES ARE THE RESPONSIBILITY OF THE WINNER. Neither the Sponsor nor any Survey Partner is responsible for any selection notifications or other communications that are late, lost, stolen, misdirected, non-deliverable or illegible due to any reason whatsoever.
