Immigrants Rights program is committed to an immigration system that keeps families together and does not determine a person's value by their immigration status or whether they have been incarcerated. Recognizing that incarceration, immigration detention, and deportation separates families, we focus our legal services on the most vulnerable in the Asian American and Pacific Islander community - immigrants facing deportation due to criminal convictions. The hundreds of clients we serve each year enable us to quickly identify emerging problem areas and to respond effectively through impact litigation, community education, and advocacy.

4b (Code:) (Expenses \$ 449,093. including grants of \$ 56,200.) (Revenue \$) National Security and Civil Rights program is committed to standing up for our cherished constitutional freedoms and liberties in the post-9/11 environment. We protect the civil rights of individuals and communities unjustly impacted by overbroad national security policies, especially Arab, Middle Eastern, Muslim, and South Asian (AMEMSA) communities. We strive to confront the day-to-day breaches of civil rights to impact the larger social and institutional dynamics that prevent the realization of equal rights through a combination of direct legal services, impact litigation, and public education and advocacy.

4c (Code:) (Expenses \$ 357,234. including grants of \$) (Revenue \$) Housing Rights program advocates on behalf of low-income residents in the areas of housing and community development.
