

**Gilley's Saloon, Dance Hall & BBQ  
Halloween Costume Contest 2023  
Official Rules**

Gilley's Saloon, Dance Hall & BBQ Halloween Costume Contest starts on Monday, October 30, 2023, at approximately 9:00 p.m. PDT and ends on October 30, 2023 at approximately 11:00 p.m. PDT (collectively the "Entry Period"). A contest will be conducted to determine which Gilley's guest is displaying the best costume and to select one (1) First Prize winner, one (1) Second Prize winner, and one (1) Third Prize winner (collectively the "Prize Winners"). A total of one (1) First Prize, one (1) Second Prize, and one (1) Third Prize winners will be selected.

The sponsor of this Contest is Gilley's Saloon, Dance Hall & BBQ, 3300 Las Vegas Blvd South, Las Vegas Nevada, 89109 (the "Sponsor"). The Contest shall be subject to these **Official Rules**, and by entering, all participants agree to be bound by the terms and conditions herein.

The Participant who received the second most crowd-applause/noise will be the Second Prize Winner. The Participant who receives the third most crowd-applause/noise will be the Third Prize Winner. In the event the potential winners do not qualify or are not willing to accept the prize, there will be an alternate winner from among eligible entries. All decisions of Sponsor are final and binding. No vulgar or inappropriate costumes are allowed. Masks are only allowed after entering Gilley's Saloon, Dance Hall & BBQ, and are not allowed on the Casino Floor. Odds of winning depend upon the number of eligible entries.
