If the Request is presented in person, the Member MUST present valid, Government-issued photo ID in order for the Statement to be released. If the completed Request Form is mailed in, the Member's signature must be notarized, and a photocopy of the Member's photo ID must be attached, before the Statement will be provided.

IMPORTANT NOTICE: Your Win/Loss Statement contains estimated win/loss information from all properties operated by the Tohono O'odham Gaming Enterprise. This information is based solely on gaming activity that has been tracked through the use of your Desert Diamond Club Card, and therefore does not constitute an accurate accounting record of all wins and losses but, instead, merely provides a record of gaming activity that has been tracked and rated for Marketing purposes.
