

## **The Outward Bound Trust's Charity Place Fundraising Terms and Conditions**

By choosing to take on a fundraising activity for The Outward Bound Trust, I agree that:

### **Participation**

1. I will inform The Outward Bound Trust Events team immediately if I am unable to take part in the event so the charity does not incur financial losses.
2. I understand that:
  - Events are organised by the event organiser, who is solely responsible for the conduct and operation of the event, including all health and safety requirements.
  - My participation in the event is conditional upon the event organiser's terms and conditions.
  - It is my responsibility to contact the event organiser directly for more information about the event and the potential risks involved.
  - I am undertaking this activity entirely at my own risk and have not been induced by The Outward Bound Trust to participate in this event, which I do entirely of my own free will.
  - I should seek medical advice from my general practitioner if I am in any doubt about my physical or mental ability to take part in this event.
  - The Outward Bound Trust cannot be held responsible for any injury or illness incurred during my preparation and/or participation in the event.
  - The Outward Bound Trust is not responsible for the event and accepts no liability whatsoever in relation to my participation in it.

### **Donations and Payment Terms**

3. I agree that any registration fees I pay for this event are non-refundable and non-transferable.
4. I will endeavour to raise as much as possible for The Outward Bound Trust and will regularly pay all money collected to the charity using the following methods:
  - Online by using a fundraising website such as justgiving.com or enthuse.com.
  - Offline by paying The Outward Bound Trust via bank transfer via the donate section of their website.
5. I will send all outstanding sponsorship money to The Outward Bound Trust within 4 weeks of my fundraising event date.

6. I will only use lawful means to fundraise and will not do anything that harms, or is likely to harm, The Outward Bound Trust's reputation, particularly in my own social media communications or if contacted by the media.
7. I agree that my sponsorship forms and online fundraising pages will make it clear that the money is not given subject to any conditions and that the monies will not be returned if the event is cancelled, or I do not complete the event.
8. I give permission for the free use of my first name, picture, image, feedback, and comments in any future publicity, advertising, fundraising materials, and/or promotion conducted by The Outward Bound Trust. If I do not wish to consent to this, I will email fundraising@outwardbound.org.uk.
9. Should The Outward Bound Trust be provided with information about my story, the charity may wish to use it in published materials, such as leaflets or on the website/social media channels. The Outward Bound Trust may also pass on my story, video, or photograph to the media, such as my local newspaper, TV, or radio station – where possible, they will seek additional consent before sharing my story. I understand that while The Outward Bound Trust makes every effort to ensure that all media coverage portrays interviewees in a positive way, the charity does not have final control over how a journalist may portray me.

#### **Data Use and Privacy**

11. I give permission for my personal information to be stored and used by The Outward Bound Trust in connection with the organisation, promotion, and administration of the event and passed on to the event organisers as required. I understand that all my information and data will be processed in accordance with The Outward Bound Trust's Privacy Policy.
