The Foundation uses a diversified revenue model that allows long-term growth of our support to the Coast Guard while mitigating the risk from a decrease in any one area. This was critical during the pandemic when event income was negatively impacted due to canceled events. As part of our 2017–2022 Strategic Plan, we are nearing completion of a human capital investment to grow our major gifts program, which will allow us to double our support to the Coast Guard in the next 10 years.

WHERE PROGRAM SUPPORT WENT



The Foundation ensures that families have the resources to recover from natural disasters, the death of a Coast Guard member, or other tragedies. We provided emergency grants to Coast Guard families who lost homes to Hurricanes Elsa and Ida, assisted with travel for families who lost their Coast Guard member to service, and partnered with Coast Guard leadership to bring holiday cheer to hundreds displaced from their homes in Hawaii due to contaminated water.

330 PROJECTS FUNDED ACROSS THE COUNTRY TO SUPPORT MORALE AND WELLNESS

Supporting wellness for Coast Guard members enhances their service and helps them cope with the challenges of their demanding duties. We piloted a national partnership with the Coast Guard Chaplain Program to help families connect and build positive, supportive relationships as well as an effort in the Northeast to combat the alarming number of military suicides through peer training. The crew of each new cutter brought into service received a grant to establish their morale and wellness priorities.

Workforce development programs enhance the service of Coast Guard members while they are on duty and also help spouses and Coast Guard veterans achieve meaningful careers. We assisted 393 members pursuing merchant mariner and aircraft maintenance licenses and funded 34 education grants for enlisted members pursuing education and professional training, as well as 175 spouses training to be nurses, teachers, business managers, and entrepreneurs.

Foundation scholarship programs reduce student loan debt, setting Coast Guard children and their families up for stronger futures. Another eight surviving children of members who made the ultimate sacrifice received full college scholarships or education booster grants for those not yet at college-age. We also funded enrichment activities for academics, student life, and athletics at the Coast Guard Academy.





Members of the board also act as ambassadors to Coast Guard units and donors nationwide, and provide significant financial support for the carrying out of the Foundation's mission.
